### **Greener Pastures? A Labor Market Theory of Climate Governance** *With Calvin Thrall & Noah Zucker*

Abstract: Climate governance requires access to climate experts: individuals with specialized knowledge of decarbonization and climate science. Here we model climate governance as the function of a competition between the state and private sector for a scarce pool of climate experts. Governments seek experts to develop and implement climate policies. Firms seek experts to affect policy choice, skirt enforcement, and measure climate risks to commercial interests. As firm interest in climate grows, the government's ability to attract experts declines, making it more reliant on the private sector for climate governance. To support this argument, we measure private sector demand for experts with unique data on U.S. job postings, paired with administrative data on government bureaucrats and procurement. Our findings offer a novel labor-based account of climate politics, contributing to the study of labor markets in political science, the sources of bureaucratic expertise, and the net effects of corporate social responsibility.

### **Private Pocketbooks for Public Goods: Advancing the State's Social Aims through Mandated CSR**

Abstract: Do firms act as complements or substitutes for the state's social development efforts? In this project, I leverage data on firms' mandated CSR spending in India from 2016-2023, and test if foreign multinationals and domestic Indian firms make efforts to advance government development priorities through their CSR expenditures. I examine the extent to which firms align their CSR spending patterns with state governments, with the Indian central government, and with their home country governments to examine the extent to which firms may be acting as agents of the state, on behalf of both their home and host countries. I find that mandated firm CSR can support the state in its public good provision efforts, but that firms rise to the occasion differentially based on their respective potential reputational, instrumental, and compliance-related gains. My project surfaces a channel through which developing states can expand their policy toolkit to achieve social outcomes that the state may be unable to achieve on its own, but highlights the principal-agent challenge that may arise when delegating social policy implementation to private non-state actors.
